

## FUNDING ASSISTANCE CONTACTS

For financial assistance within our service area, please contact one of the agencies listed below to see if you qualify for their services. Approval of paperwork typically takes up to 2 weeks. If approved, these agencies cover most course expenses including registration, textbooks, supplies, and credentialing exams. Depending on the agency, they will provide you with a list of approved services that are covered.

To schedule an appointment, please call or email one of the Agencies below. When contacting, please be sure to provide your name and telephone number. Submitting all required documentation promptly can expedite funding approval in 1 week or less. Once you successfully complete one course, additional courses may be covered.

You must email me the agency name and the email address of your Case Worker by the payment deadline to secure your seat. Failure to notify me *will* result in removal from the course due to non-payment. It is *YOUR* responsibility to email me this information, not your Case Workers.
