General Information

Description:

Piedmont Community College will be holding an Emergency Medical Responder Program. This course follows the guidelines established by the NC Office of EMS. The curriculum for the EMR educational program shall be the 2009, or most current release of the United States Department of Transportation (US DOT) National Highway Traffic Safety Administration (NHTSA) National Education Standards. Upon successful completion of the program, the Emergency Medical Responder graduate will be able to sit for the North Carolina Emergency Services credentialing exam.

Emergency Medical Responder (EMR) - 4-year certification

The Emergency Medical Responder (EMR) certification program is designed to train an individual to function independently in a medical emergency. This course provides the basic knowledge and skills needed to deliver Basic Life Support (BLS) care and is required to progress on to more advanced levels of prehospital patient care.

EMR Certification:

To obtain a North Carolina Emergency Medical Responder certification students must:

- 1. Successfully complete a North Carolina Emergency Responder course
- 2. Successfully pass a North Carolina Cognitive Examination (computer-based testing administered at any Castle World Wide testing center)

Attendance: The EMR Initial course (hybrid) combines face to face class sessions with asynchronous (self-paced) online components. To be successful, students must attend class sessions in all formats. Students may not miss more than 12 hours of classroom-based content unless approved by the program director. Asynchronous sessions allow the student to work on content at their own pace and convenience. The content will post to Moodle weekly and due dates indicated for each assignment. Incomplete assignments will impact both attendance and course grade.

Grading: The course grade will be comprised of assignments, quizzes, and exams. Assignments consist of activities and discussion boards posted within the online content. They are graded based on the stated requirements. Quizzes are short (5-15 question) multiple choice questions associated with each chapter's content. These are designed as a knowledge check prior to

exams. Multiple attempts are allowed with the highest score counted toward the grade. Section exams cover content by topical area. A mid-term and final exam cover multiple sections. Both midterm and final exams require a passing grade of 80% or higher (1 re-test is allowed for each exam). Students must maintain and complete the course with an 80% or higher overall grade. Grades are weighted as follows:

Assignments 10% Quiz 15% (total) Exams 5% each MidTerm 15% Final Exam 20%

Course Completion: To complete the course, students must complete required coursework and maintain an overall grade of 80% (and 80% on midterm and final exam individually). Students must also successfully complete the final technical scope of practice (TSOP) at the end of the course.

Certification Testing Deadlines:

- A. From an individual student's Course Graded Date (may not be the last date of the course),
 - 1. He/she has 6 months to complete a maximum of 3 exam attempts.
 - 2. He/she must complete the first exam attempt within 90 days. If a student fails to meet this deadline, his/her exam registration eligibility will be locked and he/she will need to contact the EMS Program Director for further assistance.
- B. Once a student signs an Applicant Statement, he/she must register with Meazure Learning and complete an exam attempt within 30 days.

Students who do not successfully complete the exam within three (3) attempts or six (6) months from completion of the initial EMS education program will need to complete an NCOEMS approved initial EMS education program before testing again.
